Sub: Employees' Pension (Second Amendment)Scheme, 2014-G.S.R. No. 593(E) Gazette Notification providing increased quantum of monthly pension under EPS, 1995.

Sir,

This is in continuation of this office circular No. Actuary/18(2)2008/Vol.III/5905 dated 23.07.2014 wherein it was informed that the Employees' Pension Scheme 1995 is being modified to provide a minimum pension of Rs.1,000/- per month in respect of member and widow(er)/nominee/dependent parents and Children and orphan pension of Rs.250/- and Rs.750/- respectively.

- 2. The above modifications shall come into force on the list day of September, 2014, for the financial year 2014-15 as notified vide G.S.R. No. 593(E).(Copy enclosed).
- 3. As already informed necessary changes in the application software are being carried out and the necessary software shall be released by I.S. Division for release of pension in accordance with the modifications. The minimum pension as per the notification captioned above will be released in the BRS processing cycle for the month of September, 2014 (for credit of pension in October, 2014). You may await further directions on application software amendment in this regard.
- 4. As it is an important amendment which is eagerly awaited by lakhs of EPS pensioners, you are requested to give wide publicity to the same. This may be done through press releases, letters and meetings with Employer's/Employee's Associations, e-mails, regional EPFO websites etc.

- 5. Further, while forwarding the above mentioned notifications, Ministry of Labour & Employment has also requested to prepare a list of all such court cases which are held up or stayed and relate to the demand of increase in pension under EPS, 1995. This information may be compiled for the Region as a whole and forwarded through ACC (Zones) by 15.09.2014.
- 6. Further, you are also requested to place the details of amendment Gazette Notification before the concerned courts so that the court cases are disposed off on priority.

#### NOTIFICATION

New Delhi, the 19th August, 2014

- G.S.R. 593 (P).— In exercise of the powers conferred by section 6A, read with sub-section (1) of section 7 of the Employees' Provident Funds and Miscollaneous Provisions Act, 1952 (19 of 1952), the Central Government bereby makes the following Scheme further to amend the Employees' Pension Scheme, 1995, namely:-
  - (1) This Scheme may be called the Employees' Pension (Second Amendment) Scheme (20) 4
    - (2) It shall come into force on the 1st day of September, 2014.
- It (b) Employees' Pension Scheme, 1995 (hereinafter referred to as the principal Scheme), in paragraph 12, after sub-paragraph (7), the following sub-paragraph shall be inserted, namely:
- '(7.A) The monthly member's pension including any relief payable to any existing or future member under this paragraph shall not be less than one thousand rupees for the financial year 2014-15."
- 3. In the principal Scheme, in paragraph 15, for the words, brackets and figures "sub-paragraphs (2) to (5) of paragraph 12: as the case may be.", the word and figures " paragraph 12" shall be substituted.
  - 4. In the principal Scheme, in paragraph 16,-
- (a) in sub-paragraph (2), in clause (a), after sub-clause (iv), the following sub-clause shall be inserted.
  - "(v) in all the cases, where the monthly widow pension including relief, if any, is less than one thousand rupces per month, the amount of monthly widow pension in such cases shall be enhanced to one thousand rupces per month for the financial year 2014-2015.";
  - (b) in sub-paragraph (3), for clause (b), the following clause shall be substituted, temply:-
- (b) Monthly children pension for each child shall be equal to 25 per cent of the amount admissible to the vidow of the deceased monthly widow pension payable under clause (a) at sub-paragraph (2)

Provided that the minimum monthly children pension including relief, if any, for each child of the deceased mamber shall not be less than two hundred and fifty rupees per manife for the financial year 2014-2015.

in sub-paragraph (4); for clause (ii), the following clause shall be substituted: namely is

"(a) if the deceased member is not survived by any widow, but is survived by children falling within the definition of family or if the widow pension is not payable, the children shall be entitled to a monthly orphan pension equal to 75 per cent of the amount of the monthly widow pension as payable under clause (a) of sub-paragraph (2):

Provided that the minimum monthly orphan pension including relief, if any, for each orphan shall not be less than seven hundred and fifty rupees per month for the financial year 2014-15."
